PUBLIC HEARING ON PRODUCTION PERMIT APPLICATION FOR THOMAS C. KINCAID

Call to order at 10:19 a.m. the public hearing on Application for a Production Permit for Thomas C. Kincaid.

Party representing application: Thomas C. Kincaid,

Protestant to application: None

Public Comment: None

President McGuairt declared the application uncontested.

General Manager Ty Edwards presented the application to the board. Thomas C. Kincaid, Jr has made an application for a Production Permit with the Middle Pecos Groundwater Conservation District for 1 well. The well is located on Property Id # 9807, Legal Description: 4740 135 T&STL Sec 3 N/2, approximately 15 miles Southeast of Fort Stockton on US Highway 285, in Pecos County, Texas.

The application requested authorization to withdraw 240-acre feet/year from the Edwards Trinity Aquifer. The rate of withdrawal is 260 gallons per minute and the purpose of the well will be for Irrigation Use.

The Drilling Permit was approved on May 16, 2023. Spring Branch Water Well drilled the well on September 5, 2023 and a pump test was conducted on October 20-23rd. The plan is to plant two 40-acre circles with center pivot irrigation to feed cattle on the ranch. Kincaid has agreed to allow the District to monitor the well each month along its normal monitoring route.

Adjourn Hearing and consider and/or act on **Application for a Production Permit** for Thomas C. Kincaid

President Jerry McGuairt recessed the hearing at 10:30 a.m. Ronnie Cooper made a motion to approve the production permit application as presented from the Edwards Trinity Aquifer. Motion seconded by Alvaro Mandujano, Jr.

The Board Meeting and Holiday Schedule was presented to the Board. Allan Childs made a motion to approve as presented. Jeff Sims seconded the motion.

VIII Update and Possible action on Groundwater Model Technical Memos 5-16.

- The model grid has been updated with the geologic work from LRE Water. The tech memos will be updated.
- Other tech memos using the updated grid will be updated with a general target of completing the work by the end of September.

IX Update and Possible action on San Andres efforts at RRC and TCEQ.

A preliminary hearing with the Railroad Commission was held on September 26, 2023, in accordance with Tex. Nat. Res. Code § 89.041 to Determine the Proper Plugging of Twelve Wells, Pecos County, Texas; District 08. Another Preliminary hearing is set for Feburary 6, 2023.

The District has met with TCEQ and discussed the new grant program to plug wells in Pecos County. Kelly Keel has been moved from interim to permanent Executive Director of TCEQ. We've been told by TCEQ that her appointment will help get the ball rolling with a number of their required rulemaking efforts, including their Well Plugging program. The District will continue to work with TCEQ and work through this program to help plug wells in Pecos County.

X Update on Fort Stockton Holdings, L.P. (FSH)-MPGCD Joint Study, Implementation and Threshold Water Level Update.

The Board discussed the ongoing groundwater monitoring of the FSH threshold water levels. All wells are working and operating accordingly. A link to the FSH threshold water levels is available at https://mpgcd.halff.com/Dashboard.

President Jerry McGuairt recessed the Regular Board meeting at 10:59 a.m. and called an Executive Session. Pursuant to Section 551.071 (Items IX, XI) of the Texas Government Code, the Board convened in a closed session regarding the Texas Open Meetings Act exemption covering pending litigation. President McGuairt advised that any action on this matter will be taken in open session and no action will be taken in executive session.

The Executive Session adjourned at 12:02 p.m.

The presiding officer, President Jerry McGuairt, stated that no action, no decisions, and no votes were made in executive session.

- XI Briefing and take action as necessary on following lawsuits:
 - A. Cockrell Investment Partners, L.P. v. MPGCD and its Board President in his official capacity, FSH and Republic Water Company of Texas, L.P., Case No. 23-0742 (Texas Supreme Court)(Cockrell I);

In Cockrell I, the El Paso Court of Appeals on July 13th denied Cockrell's motion for rehearing after further briefing thereby affirming the trial court's ruling in favor of the District's decision. A new deadline to appeal to the Texas Supreme Court is September 27th by petition for review. A 2nd new deadline to appeal has been approved for October 27th. On November 9th, the District and FSH filed brief responses with the Court advising that in accordance with Rule 53, each party will respond if the Court requests responses. A Petition for Review is under review by the Court.

B. Cockrell Investment Partners, L.P. v. MPGCD and its General Manager in his official capacity, and FSH, Case No. 23-0593 (Texas Supreme Court)(Cockrell II);

In Cockrell II, the El Paso Court of Appeals on July 10th denied Cockrell's motion for rehearing after further briefing thereby affirming the trial court's ruling in favor of the District's decision. The Court of Appeals issued a substitute opinion and judgment with its reasoning that there is no jurisdiction in the courts for Cockrell to pursue its claim, including the reason that Cockrell prematurely filed its lawsuit by not waiting for its motion for rehearing filed at the District to expire. On August 2nd, the Court of Appeals issued a revised opinion and judgment correcting typographical errors. On September 18th Cockrell requests extension to file appeal

with Texas Supreme Court. On October 25th Cockrell timely filed Petition for Review. On November 9th the District and FSH file brief responses with the Court advising that in accordance with Rule 53, each party will respond if the Court requests responses. On November 28th Petition for Review is "under review" by the Court.

C. Cockrell Investment Partners, L.P. v. Ty Edwards, In His Capacity as General Manager, and FSH, Case No. 08-23-00178-CV (El Paso Court of Appeals)(Cockrell III);

In Cockrell III, a hearing in front of Judge Ables occurred on May 30, 2023. The Court ruled in favor of FSH and MPGCD by granting their Pleas to the Jurisdiction. There was a disagreement with Cockrell over the finality of the trial court's judgment and fee reimbursement, which Judge Ables cleared up by signing a modified order on July 19th. August 14th is the deadline for Cockrell to file its appellate brief at the Court of Appeals. Cockrell timely filed and the District and FSH's appellate briefs were timely filed September 26th. On October 13th Cockrell filed a reply brief. Waiting for Court to advise whether there will be oral argument.

D. Cockrell Investment Partners, L.P. v. Middle Pecos Groundwater Conservation District, Cause No. P-8626-83-CV (83rd District Court)(Cockrell IV); and

In Cockrell IV, the lawsuit was filed on August 17th and served on September 13th by agreement. The District's answer and counterclaim was timely filed October 9th. FSH has advised that it will intervene and file plea to the jurisdiction.

E. Cockrell Investment Partners, L.P. v. Middle Pecos Groundwater Conservation District, Cause No. P-13031-112-CV (112th District Court)(Cockrell V).

In Cockrell V, the lawsuit was filed on August 23rd and served on September 13th by agreement. The District's answer and counterclaim was timely filed October 9th. FSH has advised that it will intervene and file plea to the jurisdiction.
